SPECIAL REQUIREMENTS:

- An applicant must possess certification from the New York State Health Department in water treatment plant operation at the time of appointment and, appropriate certification must be maintained for the duration of employment.
- A valid New York State driver's license acceptable to the Commission's insurance carrier is required at the time of appointment and must be maintained for the duration of employment.
- The physical ability to lift and routinely handle weights up to 50 Pounds is required at the time of appointment and must be maintained for the duration of employment.

DISTINGUISHING FEATURES OF THE CLASS:

This position involves high level routine and important shift work involving responsibility for the efficient operation and maintenance of Type IA water treatment plant. This type of plant contains facilities for conventional treatment and disinfection of municipal water supplies. This position will be responsible for the daily operation and management of the ELAP accredited laboratory. The work is performed under the general supervision of the Production Manager/ Lab Director with moderate level of autonomy and independent decision making. Incumbent will assist the Production Manager in treatment, water quality issues and customer service. Supervision may be exercised over the work of Water Treatment Plant Operators, Assistant Operators, laborers and other subordinate employees. The incumbent will perform all related duties as required.

TYPICAL WORK ACTIVITIES:

Monitors pump, valve and SCADA equipment used to ensure adequate distribution of potable water throughout the Bolton Point municipal water system;

Operates pumps, valves, motors and related machinery and equipment

Acts as the Lab Quality Assurance Officer;

Maintains lab documentation, instruments, supplies, coordinates sampling (internal and external), performs quality assurance duties;

Act as lead on the Lead & Copper program, coordinating sampling and outreach programs;

May coordinate or assist in coordinating with outside entities for source water sampling;

May coordinate or assist in coordinating customer concern appointments and customer follow up;

Performs maintenance work and makes repairs to machinery and equipment including but not limited to, pumps, valves, pipes, Inspects and monitors pump stations and plant facilities, Regulates and adjusts chlorinators, Washes filter beds and settling basins, Takes samples of water for testing, Makes necessary tests for control of plant operations, Keeps a log of plant operations and related records, including developing and maintaining a Filter Surveillance Program, Assists in the instruction of trainees, Supervises the work of other subordinate employees; Performs a variety of custodial and maintenance duties in connection with the maintenance of the Plant and grounds; Assists other departments with various tasks as needed.
